

National Accounts for Adagio - Release Notes

Version 9.3.11.15 (9.3A), February 14th, 2021

- o Added support for Adagio Ledger 9.3A (210115).

Version 9.3.10.14 (9.3A), December 16th, 2020

- o Fixed an issue with a batch not being deleted after the post. Actually, the batch was never posted. An error occurred while attempting to open the G/L fiscal calendar. No damage was done.
- o Fixed an issue with support for Adagio DataCare.

- o Added support for Adagio BankRec 9.3A (200929).

- o Support for Adagio Receivables 8.1A has been discontinued.
- o Updated supporting DLLs and dictionaries
- o The Active Users List has been enhanced to show the user ID, computer name, selected data information and Lanpak usage.
- o Fixed an issue with displaying orphaned batches during the data integrity check.
- o Added support for the Adagio menu.
- o Adagio Styles, Colors and LanPak licensing will be made available to National Accounts on startup.

Cash Batch Entry and Posting

- o The document number generated for cash batch entries now includes the year. The format is year, batch and entry number (YY-B-E). This avoids potential duplicate numbers with transactions entered in previous years.
- o The Total Applied is now displayed at the bottom of the cash batch entry screen. In previous versions, only the Total Unapplied was displayed.
- o Cash batch entry now checks for a negative unapplied amount and displays the message: “Applied payment amount exceeds the check amount. Do you wish to continue and save the entry?” when the entry is saved. This also prevents accidentally leaving the Payment amount field at zero after applying cash to invoices.
- o The customer name can now be edited for miscellaneous cash receipts. In previous versions, it was set to ‘Miscellaneous Cash Receipts’. The edited name is retrieved in BankRec. It is also retrieved in Ledger when any of the G/L Reference, Description 1 or Description 2 Send To fields are set to Customer Name.
- o Added support for the A/R option ‘Allow posting to control account’. It is disabled by default to prevent you from (accidentally) entering GL accounts used in Control Account Sets for the Receivables Control account during batch entry and posting.
- o The Job Description and Estimate Description can be shown in the Job/Phase/Category finder in batch entry.
- o Batches may be selected as ‘Ready for Posting’ using the spacebar.

Customer Maintenance and Inquiry

- o Fixed an issue with customer inquiry where an error appeared when opened.
- o Added an option to the Transactions tab to sort customer transactions by Date or by Type/Doc No. In previous versions, transactions were always sorted by Date when ‘Current’ or ‘Historical’ were selected and always by Type/Doc No. when ‘Both’ was selected. Also added an option to the screen to sort

customer transactions 'Ascending' or 'Descending'. In previous versions this selection had to be made by right-clicking on the grid. And when 'Both' was selected, transactions were always sorted ascending.

- o Added 'Require PO?' option on the Invoicing tab in Edit Customer. Enable to require a purchase order number to be entered in the Reference field on the Header tab in Adagio OrderEntry when entering a new order, and in the PO Number field in Adagio Invoices on the Header tab when entering an invoice. Requires OrderEntry 8.1F (2014.09.30) or higher and Invoices 9.1A (2014.10.16) or higher. A default for new customers can be set on the Customer tab in the Company Profile.

- o Added 'Print BR Receipts' option to Invoicing tab in customer. Enable if you want to print a receipt in BankRec when payments for the customer are deposited. This enables the 'Print Receipt' option in the BankRec batch for receipts retrieved from Receivables, transactions entered in BankRec or generated in reconciliation. Requires BankRec 9.2A (2014.12.18) or higher.

- o Added 'Batch by entry' option in Payment Methods. Enable to create a separate deposit batch when receipts are retrieved in Adagio BankRec (including payments originated in Adagio OrderEntry and Invoices). This is very useful if you want all deposit entries using this Payment Method to appear in the Bank Reconciliation in BankRec as separate deposit entries, such as for payments received by EFT.

- o Added support for the A/R option 'Allow edit of posted desc or reference?'. Enable the option to allow the Description 1 and 2 fields and the Reference field for posted transactions to be edited on the Transaction Details screen, accessed from the Transactions tab in Edit Customer. Use this option to allow correction or updates to these fields after posting.

- o The Terms Description is displayed next to the Terms field in Edit and View Customer. This allows you to see the description in View Customer and to see it in Edit Customer without opening finder on the Terms field.

- o The open dialog can be sized horizontally to see the full data path

- o Added support for Transport Layer Security (TLS)/Secure Socket Layer(SSL) for secure email servers when emailing documents.

- o The number of previously opened databases (saved by user) was increased from 25 to 100

- o Updated supporting DLLs and dictionaries

- o Fixed an error that occurred while opening the smart finder

- o Fixed a problem with copying a NA report table at startup. The workaround was to manually copy the contents of \SOFTRAK\NATIONAL\QRASP to the correct \QRASP directory.

- o A prompt for registration has been added to the startup.
- o The registration fields will be defaulted from the company profile fields.
